RESPONSIBLE TO: Each member of the technician support team is ultimately responsible to the Principal, but this responsibility is delegated to the Head of Science, (through the Senior Science Technician) as the identified line manager.

ROLE:

- The Science Technician's main role is to assist and support the teaching staff in improving the quality of learning in the faculty and raise student achievement
- The Science Technician is responsible for the effective day-to-day resource management of the laboratories.

FUNCTION:

In line with the agreed staffing structure, the Science Technician has three areas of responsibility:

- Responsibility to the Principal, delegated to the Head of Science (Senior Technician: Science Faculty).
- Responsibility for the smooth functioning of their work schedule and the provision of high-quality technician support to the Science Faculty.
- Responsibility for other specific duties/tasks assigned to the post.

Responsibility to the Principal

- To keep the Principal, through the Head of Science, as designated line manager, fully informed of all initiatives and developments undertaken and any issues regarding the smooth and efficient functioning of the
- To participate in the academy's annual staff review process performance management).
- To assist the Senior Technician and Head of Department with special projects and/or general matters as, and when, requested.

Responsibility for the smooth functioning of the Laboratories and supporting science teachers with the learning process

- To implement all aspects of the Science Department Health and Safety Policy.
- To check, clean, organise and distribute apparatus, equipment and materials in the Science Department.
- To provide staff and students with Hazards and Risk Assessment Information as appropriate and required.
- To support the effective delivery of science practical's.
- To attend Science Technician briefing sessions and departmental

Responsibility for other specific tasks/duties assigned to the post

- To provide ICT support to both students and teachers in order to improve students' learning and progress.
- To look after animals and/or plants in the faculty.
- To maintain the Science Department Inventories.
- To undertake ICT duties and the production of learning resources for the faculty


